VI.	Data storage period	We will process your data for the duration of your participation in procurement procedures and, if applicable, the execution of the contract, and then until the expiry of claims related to participation in the procurement procedure or the execution of the contract, or until you object to the processing of your personal data.
		If the Contractor's registration application is rejected, no longer than 12 months.
		If there is no activity on the Contractor's account for a minimum period of 24 months, the Contractor's account will be closed and the personal data will be anonymized.
		In the case of marketing consents and/or ordering the Newsletter service, until the consent is withdrawn.
		In the case of recordings of calls conducted in connection with the provision of Help Desk technical support services for a period of 3 months from the date of recording the conversation.
VII.	Data recipients	The recipients of your personal data may be state authorities / institutions, authorised to obtain data on the basis of the law, entities providing services to the Controller, also those to whom the Controller have entrusted the processing of data, in particular IT service providers (PGE Systemy).
		The recipients of your data may also include entities with which the Controller cooperate in the area of audit, tax and legal services.



VIII.	Transferring personal data outside the EEA	As a rule, your personal data will not be transferred outside the European Economic Area (hereinafter: EEA).
